These forward-looking statements include, without limitation, statements relating to our future operations, financial performance and projections, business plans, market opportunities, priorities, research and development programs, and the potential benefits of our product candidates; our financial guidance related to ELEVIDYS; expectations related to the timing of payer and medical policies; the potential financial impacts related to the termination of our adherent manufacturing agreement; our expectations related to anticipated revenue growth in the coming quarters; the potential to achieve 2025 net product revenue across our four approved therapies between \$2.9 and \$3.1 billion; and expected plans and milestones related to our various programs, including potentially expanding our expertise in areas such as CNS or cardiovascular, presenting multiple datasets from across the SRP-9001 clinical program at World Muscle Society later this year; completing enrollment of ENVISION in 2025, advancing clinical trials related to ELEVIDYS, assuming a positive pre-BLA meeting with FDA, potentially filing a BLA in 2025 for SRP-9003, engaging with FDA on SRP-9004 in 2024 and pending the results of such meeting potentially initiating a clinical study in Q1 2025, and discussing with FDA Phase 3 trial design for SRP-5051 this year.
